## TERMS AND CONDITIONS – CERTIFICATES AND DIPLOMAS

### 1. Training Costs

1.1. Training costs are set at:

- **US\$ 800** per month per participant for the six-month certificates;
- **US\$ 500** per month per participant for the one-year course;
- **US\$ 400** per month per participant for the two-year course.

1.2. Online courses will cost **US\$ 250 per month**.

1.3. Training costs include:

- Facilitation costs (practical sessions and remote support)
- Course materials and certificates
- Field Visits (our courses are 70% practical and 30% theoretical)
- Graduation Ceremony
- Admin and Exam fees

1.4. Payments will have to be made upfront. The first installment shall be paid no later than two weeks (14 days) before the training's starting date.

1.5. Payments can be made through:
